### Where does United Way get its funding?

### How does your contribution help the community?

- \$1** per week buys a scout a book, uniform and one-year membership.
- \$3** per week provides a counseling assessment for a youth struggling with depression.
- \$4** per week provides four nights of emergency shelter for a homeless teen.
- \$5** per week offers opportunities for educational day trips for seniors in the community.
- \$10** a week allows a child to receive a yearly well child check, updated immunizations, a speech/hearing screen, and a dental exam.
- \$20** per week provides one week of emergency shelter and advocacy services for a family escaping domestic violence.
