The annual fund raising drive is for securing funds to be distributed to various not-for-profit organizations located within or serving the Johnson County, Indiana area.

4b (Code:) (Expenses \$ **284,004** including grants of \$) (Revenue \$ **225,821**)

No Place to Call Home Coordination takes place in 3 parts: entry, coordinated case management and coordinated financial assistance. First, No Place to Call Home Coordination provides a single point of entry and assessment into the program for those who are homeless. Second, No Place to Call Home coordinates case management providers in the county and assigns clients to the most appropriate provider based on their presenting needs. Third, No Place to Call Home coordinates financial resources for clients to assist in addressing their housing needs. 64 households representing 227 individuals were served in this program.

4c (Code:) (Expenses \$ **149,800** including grants of \$ **149,800**) (Revenue \$ **1,075**)

Christmas Angels: To match local families with a sponsor who can provide clothing and toys to children during the holiday season. The program also partners with a local church to run the Angel Tree store. The store gives out toys and clothing donated by local businesses and individuals. 1,498 children were matched up with sponsors or received gifts from the Angel Tree store this year.
