**No Place to Call Home Coordination takes place in 3 parts: entry, coordinated case management and coordinated financial assistance. First, No Place to Call Home Coordination provides a single point of entry and assessment into the program for those who are homeless. Second, No Place to Call Home coordinates case management providers in the county and assigns clients to the most appropriate provider based on their presenting needs. Third, No Place to Call Home coordinates financial resources for clients to assist in addressing their housing needs. 47 households representing 144 individuals were served in this program.**

**Christmas Angels: To match local families with a sponsor who can provide clothing and toys to children during the holiday season.
